One hundred per cent of all financial means donated to individual children are used for their support!

LET'S GIVE CHILDREN A CHANCE is a member of the Czech Association of Non-profit Organisations (AVPO ČR) and the holder of the title Reliable non-profit organisation.

On **www.dejmedetemsanci.cz** one can choose an individual child he finds interesting, and support him in a way that he deems appropriate from a humanitarian and financial point of view.

For 4 years we have been helping children from children's homes in the Czech Republic. As of 31 December 2015, we have supported more than 2,500 children in the total amount of almost CZK 13 million.

Why do we specifically help the children who are about to leave the children's home?

For young children, the leaving of a children's home for an independent life means an immensely complex period of their immediate future and an uneasy life test. It is necessary to prepare them for their individual life while still at the children's home. These children have had a childhood which certainly cannot be considered trouble-free, and an uncertain future awaits them.

Upon leaving the children's home they are formally adults but practically still children. They lack the foundations or an example of a family, along with that they have nowhere to go and are left to fend themselves. By law they can receive a maximum of CZK 25,000 upon leaving! Can you imagine your children in their situation?

Thank you for helping us help children in the Czech Republic!

He is a very skilful and smart young man who graduated from a higher professional school, left his children's home at the age of 24, and due to our support he had the chance to spend a few years in a start-up flat. One could say that he was very well prepared for his individual life. Nevertheless, emotionally it was a very demanding period

So far I have very positively evaluated the activities of LET'S GIVE CHILDREN A CHANCE, and I am pleased by the complimentary references that we get from our cooperating children's homes and individual children. Five years ago I left the business environment in order to dedicate myself to what I had been unconsciously yearning for my whole life. I do not regret it at all. This work brings me much more satisfaction and self-fulfilment. At times it is very difficult to face the drawbacks of this kind of work, which is mainly a constantly present financial uncertainty. It is quite easy to fundraise financial means in support of individual children, nevertheless it is necessary to realize that if it were not for the people who outline the specific ways of help for those in need, the people who manage and administer this help and who are in touch with those in need, the help would simply not function.

The year 2016 will be a turning point year for our organisation. We plan to further develop our organisation and to grow our team, which means a lot of additional work. I thank the whole DDŠ team for having worked throughout all the years with love and unflagging enthusiasm. I can bring in new ideas and motivation to the organisation, however, without any support I would never achieve what we have achieved as a team. My acknowledgement also belongs to my family and mainly my husband without whose help I would not be able to do this work. I thank all of you - individuals and corporations who vested their trust to us and who have been helping us improve and change the lives of individual children! You can rest assured that your support is always directed where it is currently needed the most. Altogether with your help, the team of LET´S GIVE CHILDREN A CHANCE will do their best in order to provide children from children´s homes the easiest beginning of their independent life.



The LET'S GIVE CHILDREN A CHANCE team

In 2015, LET'S GIVE CHILDREN A CHANCE had 8 permanent staff, one externist and one temporary worker. We are a strictly female team, however, externally there are men who secure computer net, website administration and graphic design work. We cooperate with an external agency for accounting and overall accounting supervision. The organisation accounting is audited on a yearly basis. Our volunteers help us at our events and they also help us pack Christmas gifts within the 'Wishing Tree' project.

Despite our development we remain a compact team that is motivated by the meaningfulness of our work and the set goals that we manage to successfully meet due to our enthusiasm.



The powers and responsibilities of individual positions are based on the organisational plan and defined in the descriptions of individual jobs. Each Monday there is a regular weekly advisory meeting of the organisation's skeleton staff. Internal communication is primarily performed through personal contact, via email and by telecommunications tools.

Mission and specifics of LET'S GIVE CHILDREN A CHANCE

The main goal of LET´S GIVE CHILDREN A CHANCE is to facilitate the successful integration of children from children´s homes into society after leaving the children´s home and to diminish the risk of their possible social exclusion from society.

- Our help is directed to specific children in the Czech Republic who for various reasons are growing up in Czech children's homes, who are and will remain part of our society. The LET'S GIVE CHILDREN A CHANCE projects are similar to 'adoption at distance' but in the Czech Republic.
- Most of projects of DDS are unique, and no other organisation offers them on such a scale. Our projects are interconnected and complement one another.
- We have prepared our projects based on advice and received information in order to truly and effectively help those in need. We do not simply adapt our projects according to grant requests.
- We are in personal contact with the children. The children can turn to us when solving specific problems. We do not want to be just another anonymous organisation providing programmes in which children participate.
- A potential sponsor can choose a child, who in some way impresses him/her, from the list of children on the DDŠ website, and support the child in a way that they deem appropriate from a humanitarian and financial point of view.
- Our projects are based on financial and non-financial help (contact). We support and promote host care (visits of children in the host care families during weekends or holidays).
- 100 % of all donations addressed to the accounts of individual projects under the VS payment references for specific children are used for them. (Each child has a VS payment reference for payments to the particular project account.)
- Each project of the organisation has a coordinator, who maintains complete documentation, including records of children included in the particular project. The projects 'Support me...' and 'Find me...' have a joint coordinator, since they are closely related.
- A Receipt Confirmation or a Donation Agreement will be provided upon request. **Each donation is tax deductible.** Material fulfilment is also tax deductible.

How do we help children?

Through our four continuous projects that are interconnected and that complement one another. Each child can participate in each of the projects simultaneously. We consult our projects not only

with professionals but also with the young people whom we help. The projects were outlined in a way to provide comprehensive assistance.

Ideally, a child who received comprehensive assistance attained:

- Financial support for studies, which enables the child to choose a desired field of study and get ready for his future employment
- The possibility to participate in various thematic seminars within the extended weekend meetings that enable the child to gain knowledge about finances, law, personal development etc.

The financial support for studies and further education are provided for by the Scholarship Programme within the 'Help me start in life...' project.

• Financial support from a sponsor, which will help the child at the beginning of his independent life.

It is possible to save funds for a child within the 'Support me...' project.

• A host whom the child met during his stay in the children's home, who can help the child solve various matters that the child must confront after leaving the children's home.

Host care is covered in the 'Find me...' project.

- The entitlement to a Starting package = material household furnishings like bed linens and blankets, a vacuum cleaner, an iron, small kitchen appliances and drugstore goods
- The possibility to turn to our team members whom the child got to know during our cooperation, and ask them for assistance while searching for accommodation or employment after leaving the children's home.

This kind of assistance is covered in the 'Help me start in life...' project.

• A few justified wishes fulfilled, so that the child can get his driver's licence, go for a ski trip or boost his confidence, for instance by getting the chance to have dental braces.

Wishes of children are fulfilled within the 'I wish...' project.

A specific example of a child who received comprehensive assistance can be found on page 29. It is practically impossible for one to successfully manage entering independent life without any help from the outside!

The 'Support me...' or adoption 'up close' project

Project motto:

'Money isn't everything, but nothing has value without it...'.

As of 31 December 2015, 119 children had been supported as part of the 'Support me....' project. The total saved amount was CZK 1,327,965. In 2015, 14 children supported within the 'Support me...' project left children's homes, and a total of CZK 248,090 was paid out.

The **'Support me....'** project is a parallel to 'adoption at distance' but in the Czech Republic. Anybody who is interested can choose a specific child from the organisation website, and start saving money for this child. Our goal is to find a long-term sponsor for each child included in the project who will save a certain amount of money for the chosen child during his stay in the children's home, which becomes available to the child after he leaves the children's home and starts his independent life when he needs it the most. The saved amount can be used for purposes such as partial or full rent payment, furniture, further studies, increasing qualifications, etc. The money can also be paid to the young person gradually in monthly instalments.

The saved money will remain in the custody of DDŠ which guarantees the effective use of the donors' money. The project coordinator consults the use of the saved amount with each child individually. If required, the sponsor has the right to consult with regards to the aim the amount will be used for with the child and to approve this aim.

Children who do not have their own permanent sponsors who would support them until the day they leave the children's home, can be supported on a one-time basis. The child's sponsor may remain anonymous. If there is mutual interest, contact with the child can be arranged. Each long-term sponsor of a child will receive a 'Responsible Person' certificate as acknowledgement for his long-term support of the specific child.

Most children within the 'Support me...' project get supported by individual donors, however there are also corporate donors participating in this kind of help. In 2015, for instance, it was Citibank Europe.

The 'Find me...' project

Project motto:

'If you want to help a hungry man, don't give him a fish, but teach him to fish!'

Two families which completed our seminar on host care and which started helping children in this way, welcomed three older siblings through foster care in 2015. Without this, these children would have failed to get placed into a functional family.

In the 'Find me...' project it is possible to become a contact person for a child outside of the children's home, who communicates with the child during his stay in the children's home (host care). This is a relationship that ideally should last until the child leaves the children's home, and which will help the child with the uneasy transition to independent life.

Contact with a child may be a separate form of help, but it can also be beneficial addition to financial support.

Host care

is primarily suitable for older children who have little chance of returning to their biological families or of being placed in long-term foster care. The model of a functioning family is what's missing for most children in children's homes. As a result, these children often fail to establish traditional partnership relationships as adults and fail to raise their own children well.

The chance to establish social and emotional relationships outside the children's home is a huge advantage for a child! The intensity and length of visits should be agreed upon in a way that suits both parties in order not to leave one of them excessively burdened and in order to care for a mutually beneficial experience. For some it might seem ideal to meet up every second weekend, others may find it convenient to meet up once in three months. Contacting a child always begins in a form of visits in the children's home the child lives in, an environment the child is familiar with and where he feels safe. Later, it is possible to take the child for a walk or a trip. Only once the child gets acquainted with the host and once he gets psychologically ready for the visit in a family, a weekend stay in the host family can be planned. Potential hosts have the chance to participate in a Host Care Seminar within the project free of charge. We highly recommend the Host Care Seminar to anyone who has been considering host care.

Seminars for potential hosts

LET´S GIVE CHILDREN A CHANCE organizes day-long seminars introducing the issue of children growing up in children´s homes, their specific features and possible deprivational behaviours, the forms of host care, its pros but also its risks as well as details of proceedings with different authorities. The aim of the seminar is to give people insight to the host care theme from different angles, and to enable them to responsibly consider whether they feel suitable for this kind of help.

So far, 113 people interested in providing host care have participated in our host care seminars. Having completed the seminar, those who show interest in making contact with a child are given the contact to the management of a children's home located near their domicile. Further proceedings continue on the level of communication with the children's home and the particular Authority for Social and Legal Protection of Children (OSPOD) according to the applicant's domicile. We get feedback only from some of the hosts. We know that some families/individuals and children established such long-term relationships that are obviously beneficial to both parties. In some cases a friendship has developed into a permanent placement of the child/children to the family in the form of foster care.

'Host care' isn't officially defined in any law, and between the host and the child no legal relationship is constituted. Many such relationships come into existence spontaneously, for instance as a friendship of a child with a classmate from a children's home. Having received approval from the Authority for Social and Legal Protection of Children (OSPOD) in charge a children's home may allow for a provisional stay of the given child in a host family.

The 'I wish...' project

Project motto:

The best way to start a new day is to think immediately upon waking up about whether or not we can make at least one person happy.'

As of 31 December 2015, within the project 'I wish...' 863 wishes of children had been fulfilled, totalling CZK 3,620,977. Of those, 292 wishes worth CZK 881,818 were fulfilled in 2015.

The 'I wish...' project enables children growing up in children's homes to enjoy their hobbies, spend free time effectively and boost their self-esteem, which is often very weak. This greatly helps the child to become integrated into society after leaving the children's home.

We fulfil justified wishes that must be related to:

- study (school supplies, courses, school-organised stays etc.)
- effective spending of free time (sport and art supplies, musical instruments, etc.)
- correction of a medical disability not covered by insurance (glasses, braces, etc.)
- Possibility to contribute any amount (contributions are added up until the target is reached).
- The minimum amount for the 'I wish...' project is CZK 100.
- The child has a chance to choose what items or services the donations are to pay for.
- The children's homes are paid for fulfilling the child's wishes after a copy of a receipt is presented showing that the goods for which the donation was intended were purchased.

Most donations for children's wishes are given by individuals, however there tend to be more corporate donors. We are deeply grateful for the fact that many donors contribute to this kind of help repeatedly!





















LET'S GIVE CHILDREN CHRISTMAS PRESENTS or the 'Wishing Tree' project

In the 4th annual 'Wishing Tree' project **1,074** Christmas wishes were fulfilled due to generous donors for children in the total value of **CZK 1,654,353!**

In this project it is always possible to fulfil Christmas wishes of children living in the children's homes in the Czech Republic between 11 November and 12 December on the website www.stromsplnenychprani.cz!

The partner of the project was once again the company **NWT**, that runs the e-shops **Patro.CZ**, **Lypo**, **Sportilo and Outdoor - shop** where children were to choose presents they consequently wrote for in their 'Letter to Santa Claus'. Like in previous years, there was a lot to choose from. The children's wishes varied from toys for the youngest ones to sports equipment, cosmetics, and household equipment to electronics that is so particularly popular among older children and 'adults'.

We don't limit children's wishes in terms of price. At the same time we don't guarantee that the wish will get fulfilled. We leave it up to the children to choose a wish at a reasonable price where they can be almost sure that the wish will get fulfilled, or to risk that Santa Clause won't find his way to them this time. In 2015, Santa Clause made all children happy.



The 'Help me start in life...' project

Project motto:

'We can recognise a true friend in uncertain situations...'

The 'Help me start in life...' project has three separate parts: 1. The Scholarship Programme (comprehensive financial support during studies after the

- 2. Starting packages (basic material home furnishings issued when the child leaves a children's home)
- **3. Help at the start of independent life** (job and housing search assistance)

completion of the basic education level)

The 'Help me start in life...' project is focused on preparing older children for leaving the children's homes and on helping young people leaving them after reaching adulthood or completing studies. This is the organisation's most extensive and most expensive project.

For many children from children's homes entering an independent life represents an unimaginably difficult life test. It is a totally non-transferable piece of experience that is hard to imagine for those who have never gone through it, and who can't imagine what a young person in these moments must feel like. We don't realise how difficult it can be for these 'children' to solve different situations that we approach automatically. When leaving the children's home they are left on their own, with a minimum of means (by law they can receive a maximum of CZK 25,000 upon leaving), they lack foundations or an example of a family, they have no friends they could turn to.

Starting packages

contain basic household furnishings - bed linens and blankets, towels, dishes, small kitchen appliances, an iron, an ironing board, a clothes drying stand, a vacuum cleaner, an electric kettle and toiletries. The Starting packages are issued only to young people who are leaving children's homes for their independent accommodation. They meet with tremendous praise both from children's home staff and from the young people themselves.

We have already issued 61 Starting packages to children worth a total of CZK 994,369.

The contents of the packages are donated to us in the form of material fulfilment directly from the producers or vendors of the assortment. In 2015, the contents of the packages were provided to us by: SILEX (SCANquilt), Vaše DEDRA, U.T.C., Groupe SEB ČR, and Leifheit. In 2015, one Starting package was worth CZK 22,411.



We supported Lenka throughout her studies at a higher professional school. She was very pleased by the Starting package.











The Scholarship Programme as part of the 'Help me start in life...' project

In the first three years of the Scholarship Programme, we supported a total of 45 children with CZK 1,810,889. For the 2015/16 school year, the Scholarship Programme includes 32 children, whom we have pledged to support with CZK 1,069,197.

This programme enables children to study a subject they choose regardless of the necessary financial costs. If children get a chance to succeed in a subject that they enjoy, it greatly increases the likelihood that they will complete their studies in it, acquire qualifications and improve their job prospects.

All study related costs (like the costs for accommodation at school dormitories, costs for travel to school, school supplies, tuition and various courses related to study and rent in starter flats) can be financed due to the Scholarship Programme. The maximum amount of support for one child per school year is limited to CZK 50,000. Within this Programme the children have the chance to acquire a Scholarship of Merit and a Motivational Scholarship that is paid out upon completion of the given school. Secondary school, vocational, higher professional and university students are included.

Within the 'I run for children' project we as a partner organisation purchase registration numbers from Prague International Marathon for the Prague marathon and regional halfmarathons at a price set by RunCzech for non-profit organisations that further sell the registration numbers. For us it represents the means of self-financing the organisation, and we are happy to see an increasing interest in the registration numbers from both individuals and corporations. We thank all of those who supported us through their participation in some of the run races!

Beyond that, in 2015, we organized the first year of the event 'We run for children' in support of children from children's homes. 'We run for children' is a sportsentertainment afternoon for the general public.

The main goal of this event was to support a good thing, not to present an essential sports performance!

Each participant performed according to their own possibilities and abilities, the event partners paid for the participant's performances at individual posts for each one of you. Everybody can run for children!

The first year of 'We run for children' took place on Sunday, 6 September 2015 in Stromovka and Grill Park in the Prague Výstaviště with the support of the ČEZ Foundation and under the auspices of the mayor of Prague 7, Mgr. Jan Čižinský. The afternoon was hosted by **Leoš Mareš**. Among the performers of the afternoon there were not only bands like Mixle v piksle, MZH and Eddie Stoilow but also children from the cooperating children's homes. All performers appeared free of charge! Apart from the running track and the performances there were 7 sports disciplines prepared for the participants,

each of them under the patronage of a corporate partner. For children there was a children's zone with its own sports disciplines designed only for children, an art workshop, bouncing castle and popular face painting. Children from the cooperating children's homes participated in the event. Despite the bed weather there were more than 700 participates at the event and the proceedings reached CZK 299,704. We thank all of those who supported the event! We are looking forward to seeing you again in September 2016!



























The 'Children without debts' project

Project motto:

'The law is only technical and not always a reflection of justice.'

(Emil Vachek)



Children growing up in children's homes have their biological mother's permanent address registered as their permanent address even though they are seldom present there. However, their 'home' municipalities are able to assess owed amounts for household waste removal even though the children obviously have not produced it. The municipality refers the matter to a repossessor who adds a hefty fee to the debt. So it is very easy for a child to become subject to asset seizure, a fact they often find out about at the point when there is money 'leaking out of' their bank account. So a young person can easily get to start his independent life with debt. Due to amendments to the Local Fees Act similar cases should no longer occur in the future. A similar situation can occur in attempts to collect debt owed to public transport companies when a parent has not bought a ticket for a child, for instance on the journey to school.

The aim of the 'Children without debs' project is to take all necessary steps leading to debt forgiveness of children and preventing execution performance.

We are honoured to be a partner in a project of Mgr.Alena Vlachová from the law firm VEPŘEK CASKA VLACHOVÁ that provides legal advice free of charge to children within this project who through no fault of their own ended up with problems connected to repossessors; and furthermore represents them in payment management, court and asset seizure proceedings. The law firm pushed through the above-mentioned amendments to the Local Fees Act, so that in the future similar situations do not arise.

Within the project, attempts are primarily made to resolve the cases legally. But, when all other options have been attempted and the child faces asset seizure steps are taken to help the child out of debt by arranging his payment of the debt from money provided by a donor. So as with the organisation's other projects this involves directly supporting a specific child, but in view of the character of the project the money cannot be transferred directly to the selected child, because individual cases are assessed and resolved based on urgency. We even help resolve the debts of children from children's homes other than those cooperating. The stories of individual children are presented on the website **www.detibezdluhu.cz** where you can also find a list of the supported children who are also presented on the website of LET'S GIVE CHILDRENE A CHANCE.

In 2015, due to the success of Mgr.Vlachová in the court proceedings we paid debt amounts or necessary fees of only 4 children in the total amount of CZK 8,511.

A young man who received comprehensive support - Martin Kugler


Our goal is to provide comprehensive support to children. In 2015, Martin (25) left his children's home. This **graduate of a higher professional school** specializing in social work participated in our projects for 4 years and left his children's home as a comprehensively supported child, better to say a young man. The whole time we were **fulfilling his justified wishes** within the **'I wish...'** project. We found him **a sponsor who would save money for Martin during his stay in the children's home** within the **'Support me...'** project. At the time when he was leaving the children's home he had 60 thousand Czech Crowns at his disposal from which we contribute to his rent.



Part of the support within the Scholarship Programme was also the payment of costs for the starter flat where he could try to live on his own.

This year we sent a few young people like Martin to their independent life. We are in touch with the majority of them, and they are doing well.

- Donor contributions both in monetary and material form over CZK 10,000 (inclusive) are presented in our Annual report.


Naturally a question on the proportion of the operating costs and the direct support of children stands out. Given the specific features of our activities it is necessary to mention that within the operating costs we also calculate the costs that represent indirect support of children for instance, events with children, visits at children's homes etc. We give 100 % of the means to the children in whose benefit the means were donated. The operating costs of the organisation do not exceed 35 % from the overall annual turnover of the organisation. We are committed to the purposeful and effective use of all donated funds.





Provided fulfilment to children in 2015

In 2015, within the 'I wish...' project 292 justified wishes had been fulfilled, totalling CZK 881,818.

In 2015, the total amount saved for children involved in the 'Support me...' project totals CZK 501,850. In 2015, 14 children involved in the 'Support me...' project who left the children's home got paid out CZK 248,090.

In 2015, **31 children** involved in the 3rd year of the **Scholarship Programme in the school year 2014/2015** were supported in the amount of **CZK 790,724**, and we pledged ourselves to support **32 children** involved in the 4th year of the **Scholarship Programme in the school year 2015/2016** in the amount of **CZK 1,069,197**.

In 2015, within the 'Help me start in life...' project 26 Starting packages were issued to children totalling CZK 514,590.

In 2015, the winners of the design art contest received rewards in the amount of CZK 15,130.

In the 4th annual 'Wishing Tree' project 1,074 children's Christmas wishes were fulfilled in the total value of CZK 1,654,353.

In 2015, within the 'Children without debts' project 4 children were enabled to pay debts in the amount of CZK 8,511. In the table Fulfilment for children in individual children's homes the support of children within the 'Children without debts' project is not mentioned but it is included in the total support of children. The reason is that within this project we also support children from other than cooperating children's homes.

Here we are presenting amounts only related to direct financial support of children. They are also specified in the table on the previous page. As part of our main activities for children beyond just direct financial support we also arrange weekend stays, we visit children's homes, we organise seminars for potential hosts, we help children find jobs and housing, we provide individual consultations, and we carry out many other activities not specified here.

As of 31 December 2015 228 children were involved in the constant ongoing projects of our organisation.


The total amount in benefit of the direct support of children in 2015 was CZK 4,366,976.

One-hundred per cent of funds donated to specific children based on their VS payment references to individual project accounts are used to support those children.

Provided fulfilment to children for the duration of DDŠ's activities

In total, as of 31 December 2015 we have supported more than 2,500 specific children with nearly CZK 13 million!

The 'I wish...' project has already fulfilled 863 justified wishes of children worth CZK 3,620,977.

Due to the 'Support me...' project 130 children have already been financially supported in the total amount of CZK 1,662,366.

For the duration of our activities **26 financially supported children** left the children's home to whom we paid the amount totalling **CZK 334,401**.

In the previous three years **45 children** were supported within the **Scholarship Programme** in the total amount of **CZK 1,810,889**.

In the school year 2015/2016 we pledged to support 32 children in the amount of CZK 1,069,197.

Within the 'Help me start in life...' project we have already issued 61 Starting packages totalling CZK 994,369.

In the five competitions we organized we handed over rewards totalling CZK 134,592.

For the past four years, the internet 'Wishing Tree' project fulfilled 3,650 Christmas wishes of children totalling CZK 4,494,014.

In 2015, due to the 'Children without debts' project we helped pay debts of 4 children in the amount totalling CZK 8,511.

Public collection

The costs connected to the financing of individual projects for children are financed from the public collection that was launched on 20 May 2013.

The fundraising account is held at Raiffeisenbank a.s., Olbrachtova 2006/9, Prague 4. acct.no. CZ 2755 0000 0000 6072 121060.

Not only can individuals contribute to the fundraising account, but funds are also sent to it from held fundraising events and funds from SMS donations.

For each text message with the text **DMS DDS** sent to **87 777**, DDŠ receives CZK 28.50. The price of one text message is CZK 30. The project is guaranteed by the Donor forum. More information can be found at www.darcovskasms.cz.

In 2005, via donation text messages, we raised **CZK 22,401**.

In 2015, the contributions sent to the public collection account totalled CZK 54,745.

There are many who want to support a specific child, however, only a few who do realize that without the people who outline the specific ways of help for those in need, the people who manage and administer the help, and who are in touch with those in need, the help would simply not function!
